Acknowledgement and Waiver of Liability/Assumption of Risk

In consideration for me being permitted to volunteer for the Susan G. Komen Race for the Cure, I, for myself and my next of kin, heirs, administrators and executors, waive and release The Susan G. Komen Breast Cancer Foundation, Inc. d/b/a Susan G. Komen ("Komen"), its affiliates (including, but not limited to, Komen Northwest Ohio ("Affiliate")), directors, officers, administrators, representatives, past and present employees, volunteers, agents, supervisors, participants, all city and state governments, assigns, vendors, contractors, licensees, their representatives and successors and other persons (collectively, the "Releasees"), from any and all claims, liabilities, actions, demands, expenses, and attorneys' fees arising out of my volunteer activities (collectively, "activities").

I understand that the nature of my activities may involve physical activity, contact with unidentified or unfamiliar persons or other potential risk of bodily injury or damage to property and I hereby voluntarily assume full and complete responsibility for, and the risk of, any injury (including death), accident or lost/stolen property which may occur during my activities.

I attest that I am medically and physically able to volunteer. If I experience any doubt as to my ability to successfully and safely volunteer, I take full responsibility for consulting a physician. I consent to emergency medical care and transportation in the event of injury to me as medical professionals may deem appropriate. This Release extends to any liability arising out of or in any way connected with the medical treatment and transportation provided in the event of an emergency, including, but not limited to, negligence emergency rescue operations.

I agree to observe and obey all laws, rules and safety procedures that relate to my activities. I agree to exhibit appropriate behavior at all times and conduct myself in such a manner as not to diminish the reputation of the Releasees or endanger the safety of or negatively affect this event or any person, facility, or property.

I agree to maintain the confidentiality of any information about each Releasee's business operations, organizational structure, employee information, financial operations, marketing strategy, organization, donor lists and amounts, plans for upcoming events, current or proposed business transactions and sponsorships, and any proprietary information such as computer software and programming and the like that is not otherwise publicly disclosed. I will not use any confidential information in any manner that would be detrimental to a Releasee.

Miscellaneous

This Release shall be construed under the laws of Ohio. In the event any provision of this Release is deemed unenforceable by law, (i) Affiliate shall have the right to modify such provision to the extent necessary to be deemed enforceable; and (ii) all other provisions of this Release shall remain in full force and effect.
